Letter of Intent (LOI) for Frequency Assignment (THIS IS NEITHER A FREQUENCY Sub.: ASSIGNMENT NOR A LICENCE) - On NIB/NPB/ Co-sharing Basis payment - regarding.

Sir.

I am directed to refer to your online license application ID no. 2020228656, undertaking dated 28.11.2019 on the above subject and to inform you that this Ministry hereby conveys its Letter of Intent (LOI) for establishing Wireless Telegraph (WT) Station, for operation of FIXED-2 (1 Main + 1 Stdby), Radios, for establishment of Community Radio Station (CRS) subject to the following:

This Letter of Intent (LOI) is valid for a period of 60 days from the date of issue. 1

You are required to make the following payment of spectrum charges in advance (License Fee, 2 Royalty charges and additional royalty, per annum as applicable) as prescribed vide order No. L-14024/07/2004-WF dated 11.12.2018 in advance (License Fee, Royalty Charges per annum, as applicable) till a final decision is taken on the pricing for spectrum. The payment is to be made within 60 days from the date of issue of this LOI so that Decision Letter for frequency assignment may be issued:

Spectrum charges as mentioned above shall be paid through Non Tax Receipt Portal (NTRP) 3. of Govt. of India, https://bharatkosh.gov.in. For any query regarding payment through Bharatkosh, please contact 01123328280 or email at support.pfms-dot@gov.in.

On receipt of above payment, Decision Letter to grant license indicating frequency assignment, technical details, number of equipment, location of stations etc., for operation of wireless stations will be issued, which will be valid for a period of one year from date of issue of Lol.

- In case, period of validity of requested license is more than one year (maximum five years), above amount may be paid in advance for entire period of license or annual installments in advance.
- If the payment is not received within the period of 60 days from the date of issue of this letter, the application will be treated as cancelled and you shall have to apply afresh. The frequencies shall be freed for being assigned to others and no further correspondence shall be entertained in the matter.
- The stations will be operated by Indian Nationals only trained / authorized by the licensee. 7.
- Terms and conditions applicable as detailed in Annexure-I. OPERATION SHOULD NOT BE COMMENCED BEFORE GRANT OF WIRELESS OPERATING LICENSE.

The frequency assignment is subject the following conditions:-

- The allotment of spectrum is provisional and subject to Govt's decision on allotment & pricing of spectrum;
- II. In the event of final decision to allot spectrum only through auction process, the provisional allotment of spectrum shall be withdrawn;
- III. In case the provisional allotment of spectrum is withdrawn, payment made towards spectrum charges or part thereof shall not be refunded;
- IV. In case the provisional allotment of spectrum is withdrawn, you shall obtain Non Dealer Possession Licence (NDPL) for possessing the wireless equipment, or return the equipment to a DPL holder, or shall be disposed off the same as per procedure.
- V. The revised spectrum charges, as finally determined through market related mechanism or otherwise, as may be applicable, shall be paid by you from the date of Letter of Intent (LoI) for provisional allotment of spectrum.
- 2. Further, upon Shift/ change in policy from administrative allotment and issue of due notice for such change to make appropriate arrangements, etc., the same shall be complied with within three months from date of issue of such notice by you.
